### Safeguarding Statement

*At Kempshott Junior School we respect and value all children and are committed to providing a caring, friendly and safe environment for all our pupils so they can learn, in a relaxed and secure atmosphere. We believe every pupil should be able to participate in all school activities in an enjoyable and safe environment and be protected from harm. This is the responsibility of every adult employed by, or invited to deliver services at Kempshott Junior School. We recognise our responsibility to safeguard all who access school and promote the welfare of all our pupils by protecting them from physical, sexual and emotional abuse, neglect and bullying.*

### Overview

The School began receiving the Sports Premium in September 2013. There is a basic grant to all schools and this is topped up by a per pupil element. The purpose of this funding is to support the provision of quality physical activities within the school. It can be used in many ways but the school is accountable to Parents and Governors for the way in which it is spent and we are required to publish this information on our website.

### Objectives

1. The Sports Premium will be used to provide additional opportunities in physical education. This may be on an individual, group class or whole school level.
2. The Sports Premium will be used to support and improve progress and to raise achievement for pupils in physical education
3. Additional funding may be used to address any underlying inequalities between children in the school for example access to clubs, transport and equipment costs.
4. We will ensure that the sports premium funding benefits all pupils.

### Strategies

1. The Sports Premium will be clearly identifiable within the budget
2. The Headteacher, in consultation with staff and Governors will decide how the Sports Premium is spent for the benefit of pupils.
3. The school will assess what additional provision might be appropriate for individual pupils
4. The School will be accountable for how it has used the additional funding. The Headteacher will report to the Governing Body on how effective the Sports Premium funding has been in achieving its aims
5. We will publish online information about how we have used the Sports Premium and the impact that it is having for pupils.
6. We will seek to develop strategies for Sport beyond the School in partnership with Basingstoke Primary Schools PE & Sport Association and other agencies to provide opportunities that might not otherwise be part of the school day or extra-curricular provision.
7. We will track and evaluate the impact of the Sports Premium spending to ensure that we can demonstrate the value that has been added to physical education at the School.

### Outcomes

This policy will play an important part in the physical development of all pupils. We will ensure that pupils are treated equally and that the additional funding is used well to enhance sporting provision within the school and on occasion support children with a particular talent. The school will use the funding to promote the achievement and progress of all pupils. Through wise use of this additional funding we are fully committed to ensuring that the individual needs of the child are met. As a result of the additional funding we expect to enhance sports provision for all children.
